5.2 Additional IS Medals can be ordered after the event.
The cost of these is not covered by the entry.

NOR 6. EQUIPMENT INSPECTION

- 6.1 A boat identified for an on-the-water equipment inspection will be signalled from Technical Committee Vessels by equipment inspectors and the boat shall follow their instructions.
- 6.2 Where a weight limit applies crew may be weighed on date indicated in NOR 1.

 The location for crew weighing will be given in the Sailing Instructions. The Person in Charge is responsible for ensuring that a boats crew has successfully weighed in







NOR 7. LIFTING AND BERTHING ARANGEMENTS

- 7.1 When arriving by road and pre-booked with the HYC marina office, a free lift in and out is available on the HYC marina cranes on the dates given in NOR 1.
- 7.2 Free trailer storage is available for the duration of the event.
- 7.3 Free berthing will be available in the HYC marina or commercial harbour from the 7th to 10th September. Space in the commercial harbour will be allocated by the HYC marina office.
- 7.4 When pre-booked with the HYC marina office and organizing committee, discounted berthing is available for a limited number of boats in the HYC marina for boats:
 - Prior to the event: Arriving from the 5th onwards who were also entered in the J -Cup (Max 6 slots available)
 - After the event: For boats entered in the HYC Autumn League
- 7.5 Please ensure that you <u>book</u> your lift in time slot and pay with the marina office for any berthing outside of 7.3-7.4.
 - Boats are asked to co-operate with harbour and marina staff at all times.
- 7.6 There are no lift in after 20:00hrs on Sept 7th.
- 7.7 Boats intending to have their crew sleep aboard must be berthed in Marina & not fishing harbour

NOR 11. CLEAN REGATTA

ICRA National Championships is a 'Clean Regatta' and is fully supportive of sustainability of our land and marine environments. We would also ask that you try and eliminate any plastic disposable bottles or wrapping in your consumables on board and to recycle any necessary plastic when ashore. The organisers would encourage competitors and supporters to do their bit on land by choosing to cycle, car share or use public transport to get to the event.

NOR 12. Risk Statement

Rule 3 of the Racing Rules of Sailing states: 'The responsibility for a boat's decision to participate in a race or to continue racing is hers alone.'

Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By











taking part in the event, each competitor agrees and acknowledges that:

- a. They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- b. They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- c. They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- d. Their boat is in good order, equipped to sail in the event and they are fit to participate;
- e. The provision of a race management team, patrol boats and other officials and volunteers by the event organizer does not relieve them of their own responsibilities;
- f. The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
- g. It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event;
- h. For offshore races, they are responsible for ensuring that their boat is equipped and seaworthy so as to be able to face extremes of weather; that there is a crew sufficient in number, experience and fitness to withstand such weather; and that the safety equipment is properly maintained, stowed and in date and is familiar to the crew .
