### **SAILING INSTRUCTIONS AMENDMENT 2(a)**

**This amendment supersedes amendment 2 and Sailing Instructions 9 and 10 are hereby amended to read as follows:**

#### **9. HEARING REQUESTS AND SCORING ENQUIRIES**

9.1. The Protest Time Limit is **60 minutes** after the last boat of the fleet that the protestor is racing in finishes the last race started on a day or the Race Committee for the protestor's fleet signals 'no more racing today', whichever is later. Fleets for the Regatta are deemed to be Inshore and Offshore, each of which will have a number of Classes assigned to race as part of it.

9.3. The time of expiry of the Protest Time Limit shall be published at:

9.4. Notices of protests, including those by the Race Committee or Protest Committee, to advise parties of protests to which they are a party will be posted within 30 minutes of the expiry of the Protest Time Limit. Notices shall be posted at:

The listing of a boat on this schedule shall constitute informing her of a hearing as per RRS Rule 60.2(d). This changes RRS Rule 60.2(d).

9.5. **The protest flag exemption for boats less than six metres shall not apply. This changes Rule 60.2(a)(1).**

## **10. PROTEST HEARINGS**

Protest hearings will be held on the Tuesday following the race in question at 1930 in Howth YC. On the last scheduled day of racing, protests will be held on that day.
